The date for EuroDIG 2021 is confirmed, but how the situation with regard to the pandemic will look like next year is uncertain.

We understand there is a great desire to meet in person and have informal exchanges. This year we have built strong ties to the scientific community in Trieste and we would all like to continue the debate on how to ensure a sustainable governance of the Internet.

Therefore, EuroDIG 2021 will be planned as a hybrid format, with both an on-site event in Trieste but all participants being encouraged to connect at the virtual platform. We want to put the remote participants in the centre of the meeting!

We understand there is a great desire to meet in person.

We will invest additional efforts to constantly connect remote and onsite participants, by trying out new session formats, that also meet social distancing measures and avoid crowded rooms.

We are planning with flexibility; in the worst case we can go back to a fully virtual meeting and in the best case we will see many of you in Trieste.



What is EuroDIG?

Launched in 2008, EuroDIG, the European Dialogue on Internet Governance, is a unique annual event that brings together Internet stakeholders from throughout Europe (and beyond), and from across the spectrum of government, industry, civil society, academia and the technical community.

Stakeholders and participants work over the course of each year to develop, in a bottom-up fashion, a dynamic agenda that explores the pressing issues surrounding how we develop, use, regulate and govern the Internet. EuroDIG participants come away with broader, more informed perspectives on these issues and new partners in responding to the challenges of the information society.

The 14th EuroDIG will take place on 28 – 30 June 2021.

This includes a Day 0 in which organisations and initiatives can present their work, and engage with the community, followed by two full days of multi-stakeholder workshops, high-level sessions, and new formats.

European Dialogue on Internet Governance brings together Internet stakeholders from throughout Europe.

Who organises EuroDIG?

EuroDIG is organised in a bottom-up manner. The content of the programme is initiated and shaped by all participating stakeholders from civil society, the business sector, the technical and academic community as well as European governments, institutions and organisations. The EuroDIG secretariat will assist throughout the programme planning process supported by all institutional partners.

Every year EuroDIG takes place in another European country thus, bringing in new people constantly. The local community always plays a big role in the planning process.
